You must specify which item your comment pertains to or if it is for general public comment. The County Liaison will then read it into the record during the meeting.

White in person, you may speak for up to three minutes.

Please note that the above instructions apply to public comment which will be read into the record by the liaison during the meeting in lieu of traditional oral public comment.
